Reporting to the Senior Manager of Information Systems and GIS, the primary responsibilities of this role include:

- Developing and executing spatial analysis and presentation projects that integrate data from diverse sources;
- Conducting research on geographic database matters and updating departmental databases as required;
- Developing analysis methodologies for data from different organizations;
- Responding to enquiries from the public, staff, and elected officials with respect to various geographic and mapping issues;
- Supporting planning staff in the collection and application of digital GIS data;
- Building custom modeling/analysis techniques for mapping requests and developing mapping products for public hearings, open houses, and committee and board meetings.

Our ideal candidate is:

- A strong researcher with the ability to create meaningful maps, plans, graphics and other presentation materials from GIS data;
- Organized, analytical and creative when it comes to problem solving;
- A strong communicator with the ability to effectively relate to others both orally and in writing;
- Educated in GIS at the University level with a related Bachelor's degree;
- Experienced in land use related GIS applications, with over one up to two years of directly related experience including experience using ESRI's ArcMap and ArcCatalog, editing and maintaining geodatabases and SQL programming;
