We are pleased to announce this exciting opportunity for you to join our team and make a BIG impact on watershed and wetland health in B.C. The Wetlands Workforce (WW) project will deploy work pods in the field to support the maintenance, monitoring and inventory of restored wetland sites across B.C., engage in planning activities related to the restoration of future wetland restoration sites and inventory of natural wetland sites for the development of better wetland management tools. The WW Project is supported through the Province of BC's economic stimulus fund to provide temporary employment for a minimum of 100 people. Work pod activities will be supported in part by direct employment as well as multiple sub-contracts provided to partnering conservation organizations across the Province.

The BCWF is hiring several positions for the Wetlands Workforce project. Other positions include:

- Field Crew Supervisor

This is a full-time, contracted position starting from hiring date and ending December 15, 2021. Evenings, weekends and/or extended hours may be required to accommodate activities and events. At the current time, there is no clear opportunity for extension as this is a one-time fund.

You will be expected to primarily work remotely (e.g., home office), collaborating virtually with a headquarters team, field crews, partners, and First Nations communities. Applicants living outside of the Lower Mainland, but in British Columbia, will be considered.



Job Purpose

Reporting to the Wetlands Workforce Project Manager and the Director of Conservation Stewardship, the Geographic Information Systems (GIS) Coordinator will join our headquarters team to develop and analyze mapping applications and tools for the WW projects.

Core Responsibilities

- Create maps and graphs, using ArcGIS or QGIS and data collected through FileMakerGo, GPS and other data collection equipment.
- Source and analyze provincial spatial datasets for stratification of wetlands in B.C.
- Determine appropriate processing and GIS analysis of collected data in collaboration with the WW team.
- Produce appropriate field maps to be used for data collection and navigation in the field using ArcCollector and Avenza.
- Create and maintain an online storymap of the WW project progress.
- Analyze collected data to produce reports and appropriate maps on wetland assessments.
- Assist with streamlining field data collection and processing.
- Maintain organized and accurate geodatabases.
- Compile geographic and demographic data from many sources.
- Collaborate with partners to access and create maps and aerial imagery.

- Experience using Python to create and modify scripts for modeling and data processing
